Chief Brickell: Called the meeting to order at 10:18.

Approval of Agenda: Motion to accept agenda made by Heather Simons, second by Silas. No discussion, motion passed.

Russell Hearing:

• Attorney Dingledine stated her concern that documents were provided to Council Members in advance of the hearing. She objects to the distribution of these documents.

- AAG Jacob Humbert stated his position that the documents wouldn't taint Council Members opinions. He posed no objection to requiring Council Members to return what that had received and state what materials that had reviewed previously.
- Hearing Officer Wesley Lawrence noted that Attorney Dingledine had passed out a packet of information that Council Members were looking at. He queried Council Members regarding what they had previously reviewed and if they believed they could be fair given that they had possessed this information prior to the start.
 - o Chief Brickell opened two, has not reviewed documents.
 - o Director Simons impartial, looked at material.
 - o Colonel Elovirta Did not have time to read, thumbed through.
 - o Sgt. Gould- reviewed a few attachments from email and thumbed through.
 - o AAG Scherr Briefly review a couple documents.
 - o Gary Moore Has read emailed packet and read hand out spiral binder
 - o Sheriff Benard Only read case notes from Cindy (was asked how he knew).
 - o Constable Loomis- Browsed some attachments and spiral packet.
 - o Major Scribner glanced through attachment and through spiral-bound documents.
 - o Captain Major- Looked at attachments and through spiral-bound documents.
 - o SA Erica Marthage Has not looked at any materials.
- Dingledine asked that any emailed materials be disregarded and collected.
- Gould disclosed he is a crash instructor during the 104th Basic. No objection from anyone regarding his participation.
- Dingledine noted some documents were never seen before.
- Recruit Murphy proper heading with different recruits' work, not sure why provided Russell Report (has nothing to do with case).
- Email from Russell to Cindy Taylor-Patch
- AAG Humbert email and Russell Report will not be offered into 1055.
- AAG Humbert presented case of Russell's suspension from 104th due to four failures (61% Motor Vehicle Law Quiz, Firearms standard, 55% on Motor Vehicle Quiz #6 and failure of Patrol Procedures Final Scenario #3).
 - O Council Rule #2 and academic failure policy in the Recruit Manual outline the grounds for suspension from Basic Training. Council needs to ratify expulsion, not ratify and impose remedial action.
 - State asking to ratify suspension and temporary expulsion, lasting a defined period of time.
- State called Director Taylor-Patch as witness. Testimony was provided.

Break for lunch 1:10 - 1:45

- State called Executive Director Gauthier as witness. Testimony was provided.
- State called Officer Jason Williams as witness. Testimony was provided.
- Dingledine requested that Russell return for final scenarios and have opportunity to test.
- Dingledine called Chief Dodge to testify. Testimony was provided
- Dingledine called Paula Russell to testify. Testimony was provided.
- Dingledine called Chief Bombardier to testify. Testimony was provided.
- Dingledine moved to admit exhibits 1-5,6,7,10,11,12 into evidence.
- Exhibits 2,3,4,5,6,9,10, admitted for the State.

- No rebuttal witnesses.
- Dingledine requested that the Council deliberate as soon as possible.
- AAG Humbert reported that the State would like findings.
